Is an IRA Charitable Rollover Right for You?

The IRA Charitable Rollover or Qualified Charitable Distribution is a special provision allowing taxpayers to make tax-free charitable gifts directly from individual retirement accounts to eligible charities including the Iowa Knights of Columbus Charitable Foundation.
